A4E PRIVACY POLICY

A4E respects the privacy of every individual who visits our website or sends us emails. Therefore, we comply with applicable data privacy legislation with regard to the processing of personal data. This Privacy Policy describes how A4E processes and protects your personally identifiable information that we collect when you are accessing or using our website or services (such as when you attend our events) or when you contact us.

INFORMATION YOU PROVIDE TO US

You may have the opportunity, via our website or other means, to choose to provide us with personal information about you. This information may include, but is not limited to, your name, email address, job title, employer and phone number.

If you choose to share any personal data with us via our website or via email, we may store it and use that information to assist you with any questions you may have. When you contact us, we will keep a record of our correspondence.

We may also store data that you voluntarily provide when registering for A4E events in order to keep you informed about that event or other events of a similar nature.

You will receive general information from us only if you choose to do so. Once your consent is indicated, you will have the possibility to contact us in case you no longer want us to use your personal information for those purposes.

SHARING OF YOUR PERSONAL DATA

A4E does not sell, rent, loan, trade, or lease your Personal Data collected online or offline to anyone, nor do we share it with other organisations.

However, to avoid people receiving multiple invitations to the same co-sponsored event, A4E reserves the right to share your first name, last name, and employer with partner organisations for the purpose of de-duplicating the final invitation list. Except as described in this Privacy Policy, we will not share your phone number, email address, or any other contact information with our partners.

In addition, under certain circumstances, A4E may be required to disclose your personal data (including personally identifiable information) when such action is necessary to comply with valid requests by public authorities, and/or to comply with a current judicial proceeding, a court order or legal process, and/or in connection with a verified request relating to criminal investigation or alleged illegal activity.

SECURITY

A4E uses secure data networks that are protected by firewall and password protection systems that are consistent with industry standards. A4E's security and privacy policies are periodically reviewed and enhanced as necessary. Only authorized individuals have access to the information provided by A4E contacts.

OPT-OUT OR CHANGE YOUR PERSONAL INFORMATION

You have the right to access, modify, correct and remove your data from our database at any time. You have the right to ask for a copy of the information we have about you.

A4E provides you with the opportunity to access, review, update, and delete any personal data we process. If you ask us to delete your data, we will do so. A4E provides users the opportunity to opt-out of receiving communications from A4E:

- you may update your personal information previously provided to us or unsubscribe at any time by clicking on the link at the bottom of any emails you receive from A4E or by contacting us at privacy@a4e.eu.
- you may choose to receive only specific communications or none at all

In order to avoid a situation where repeated, unwanted contacts could occur, we will keep a record of your request to be removed from the database.

Please note that we may be required to retain and use your information if necessary to comply with legal obligations or to resolve disputes.

COOKIES

You may visit our website anonymously. Except as described in this Privacy Policy, we do not collect identification data of our visitors.

We do, however, use cookies (small data files that stay on your computer or other device and let us know when and how often you visit our site) and other technologies to keep and track general information about website usage, and ensure you have the best possible experience when using our website. Cookies do not identify the individual user, just the computer used.

Cookies and other similar technology can make it easier for you to use the website during future visits. Cookies only record which areas of the site have been visited by the computer in question, and for how long. This information allows A4E to understand how our website is being used, which helps with planning future website content and a better user experience. We will not use cookies to collect personally identifiable information about you.

Allowing us to create a cookie does not give us access to the rest of your computer and we will not use cookies to track your online activity once you leave our site. However, if you want to restrict or block cookies, you can do it through your Internet browser settings. Most browsers will allow you to erase cookies from your computer hard drive, block all cookies, or receive a warning before a cookie is stored. Please refer to your browser instructions to learn more about these functions.

We do not knowingly process personal data from anyone under the age of 16. If you are under 16, please do not attempt to register or send any personal data about yourself to A4E. If we learn that we have collected personal data from a child under age 16, we will delete that data.
